Eye Contact	If this product comes in contact with eyes: Obtain medical advice / attention without delay Immediately hold eyelids apart and flush the eye continuously with running water. Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids. Advice for firefighters
